I want to address something regarding the notes from the May 25th Meeting. It seems like a specific point was either not captured or omitted intentionally from the minutes you provided. I understand note taking can be challenging, but it is important for us to accurately record everything discussed, especially regarding vandalism. To ensure we are all on the same page, I would like to go over a specific point to make sure it is documented correctly.
